#### **Procedure**

To become a Justice of the Peace you must:

- I. Complete an application for appointment form and attach the required documents specified in the form.
- II. Lodge the application with the Justice of the Peace Association (JPA). After the application has been reviewed the applicant will be contacted to arrange an interview. The Following steps will then be followed.
  - a) The application will be checked for completeness and eligibility
  - b) An acknowledgement of receipt of the application will be issued
  - c) A criminal record check will be requested from the police force
  - d) Upon assessed as meeting the eligibility criteria for appointment the applicant's name will be placed on a schedule of appointment for the Minister's recommendation.
  - e) Following recommendation the schedule of appointment will be forwarded to the Cabinet of Ministers for approval.
  - f) If approved the applicant will be sent notification of his/her appointment and advised of the date of training prior to taking the oath of office.
  - g) After the oath of office has been taken a warrant of appointment will be issued by the Governor General that confirms the applicant's appointment.
  - h) Other pertinent information including a Justice of the Peace registration number will also be issued.

- i. One certified passport size photo
- ii. A copy of national ID
- iii. A recent police record and
- iv. Certificate of citizenship (if applicable)
